MARKER AND MONUMENT REGULATIONS SECTION BY SECTION

Rules That Apply to All Sections

Family names are not permitted on the back side of any memorial, because of the imposing of the wrong name in the direction of other spaces being memorialized.

On lots where there are no restrictions, the size of memorials can be up to 2/3 of the width of the lot, and up to 14" wide front to back (this refers to base size, not foundation size), unless it is located in a section that has size requirements.

Only one memorial is permitted per burial. A family monument with footstones is permissible.

Semi-Annual cut off dates for accepting foundation orders:

Memorial Day April 1
Winter October 15

No foundations will be guaranteed for installation after these dates.

No foundation will be poured if there is any outstanding balance due on the lot or services rendered.

The lot owner must sign all foundation orders; if the lot owner is deceased, the foundation order must be signed by the person who signed the interment order.

Memorials must be either granite or bronze, marble will not be permitted, as marble is soft, porous, and not durable. No memorial will be allowed on any lot until all related charges are paid.

Sections 1-2-3-4-5-6-7-8-8 1/2-9-9 1/2-12-16-Public Ground

These are all in the old section of the cemetery. There are no special requirements here, as any type of memorial may be used as long as it is the correct size for the lot.

Section 10

This section requires all memorials not to exceed 8" high.

Sections 14-14SS1-15

These sections require flush grass markers.

Section 17 - Veteran's Field of Honor

All veterans memorials will be the government-issued bronze on granite. The family members must use the matching government type bronze markers. All markers will be set on a moonlight gray granite base.

Bronze vases are permitted in the markers.

Section 19 and 30

These sections require flush bronze markers. Vases are permitted in the marker.

Bronze markers without a granite backer will be set on a pre-cast foundation.

Section 20

This section has one row of grass markers (in the front) and two rows of monuments.

The monument must be at least 8" thick and can be up to 32" high, bases can be up to 16" wide front to back. All foundations are to have a 4" margin.

Grass markers may be bronze or granite.

Sections 20 1/2-21-28-31-35-37-38

There are no restrictions on memorials.

Section 22

This section has monument and grass marker lots. There are no restrictions on memorials.

Section 22 SS1

These lots each contain one grave space. All memorials must be bevels no higher than 8".

Section 22 SS2 & SS3

These sections are Babyland. The memorials must be 20" long, 10" wide, 6" high bevels.

Section 24

This section is laid out for monuments and grass markers. No size restrictions on memorials.

Any lot not designated as a monument lot on the map can use only flush grass markers of bronze or granite.

Section 27

This section is laid out for monuments and flush grass markers.

The north part of this section is laid out with a row of monuments and two rows of grass markers.

There can only be one upright monument per four-grave lot. No size restrictions on monuments.

Any lot not designated as a monument lot on the map can use only flush grass markers of bronze or granite.

The south end is all four-grave monument lots with one monument per lot.

Minimum Size: 36" long, 8" wide, 18" high (die)
48" long, 14" wide, 8" high (base)

Maximum Size: Not over 2/3 of lot width.

Section 29 Babyland

This is a grass marker section only. Granite not to exceed 20" wide.

Section 36

Single Monument Area Only-
Lot #297 through 304 and 363 through 381

GLEN HAVEN MEMORIAL GARDENS

Size required: 24" long, 8" wide, 26" high (die)
34" long, 14" wide, 8" high (base)

These monuments will be set on a continuous foundation and customer will pay for size of stone plus 4" margin.

Center Section of 36

All roadway and walkway lots are 4-grave lots: one monument per lot- these monuments will be centered on lot.

Size requirements:

Minimum Size 48" long, 8" wide, 24" high (die)
60" long, 14" wide, 8" high (base)

Maximum Size 96" long, 10" wide, 30" high (die)
114" long, 16" wide, 10" high (base)

2-Grave Lots of 36

Size Requirements:

Monuments can only be

Minimum Size 36" long, 8" wide, 20" high (die)
48" long, 14" wide, 8" high (base)

Maximum Size 42" long, 8" wide, 26" high (die)
54" long, 14" wide, 8" high (base)

3-Grave Lots of 36

Size Requirements:

Monuments can only be

Minimum Size 42" long, 8" wide, 20" high (die)
54" long, 14" wide, 8" high (base)

Maximum Size 54" long, 8" wide, 26" high (die)
60" long, 14" wide, 8" high (base)

4-Grave Lots of 36

Size Requirements:

Monuments can only be

Minimum Size 48" long, 8" wide, 26" high (die)
60" long, 14" wide, 8" high (base)

Maximum Size 60" long, 8" wide, 30" high (die)
78" long, 14" wide, 8" high (base)

The foundation for these monuments are figured at the actual size of the base and adding 8" to length and 4" to width.

Section 39

This section is laid out for 8-grave lots only.

There can only be one upright monument per 8-grave lot.

Minimum Size 60" long, 8" wide, 30" high (die)
78" long, 14" wide, 8" high (base)

Private Mausoleum

Before a private mausoleum is erected, a trust fund must be established to provide for the future care of such structure and its surroundings, in an amount that is judged sufficient by the Cemetery. No private mausoleum structure may be erected which occupies more than 25% of the entire lot area.

Section 1 (Veterans Section)

All veterans memorials will be the government-issued bronze on granite. The family members must use the matching government type bronze markers. All markers will be set on a moonlight gray granite base. Bronze vases are permitted in the markers.

Sections 2-4

All markers must be flush bronze. Markers must have at least a 2" granite or cement extension around it.

Bronze vases are permitted in the markers.

Section 5

This section is laid out for upright monuments only, with no size restrictions.

Section 7 (Babyland)

All markers must be bronze. Bronze vases are permitted in the markers.

The amount of \$25.00 for each grave memorialized will be deposited in the memorial trust fund which is in keeping with the original program that was presented to the families of this community before its acquisition by Earlham Cemetery in 1968. The purpose of the fund is for the periodic leveling of memorials and the removal of memorials that becomes necessary at the time of burial.

When memorials are purchased from the cemetery, 10% of the sale price is placed in the cemeteries Perpetual Care Trust Fund for the future care of the lot.

Cemetery officials have authority to reject any plan or design for any memorial which, because of size, design, or inscription, is unsuited to the lot on which it is to be placed.

Memorial dealers will abide by all rules and regulations of the cemetery.
